VOTER INFORMATION

Voting Eligibility

You must be a US citizen in good standing (not convicted of a felony or adjudged mentally incompetent without restoration of your right to vote) and a legal resident of Washington State, 18 years old by election day, a county resident, and registered to vote 30 days before the election.

Where to Register to Vote

County Courthouse (Auditor's Office), your City Hall, school secretaries, all branches of the North Olympic Library System, and Driver's Licensing Offices. You can register on line at www.Clallam.net. Link to Voting & Elections.
